- I am the sole and best judge of the level of my ability to participate in this activity and I am aware of the additional risks to which I am voluntarily exposing myself and fully aware of the situation;
- I acknowledge that I must wear a helmet;
- I know that upside-down manoeuvres are authorized solely for the AcroBag and formally prohibited in other parks.
- I agree to pay such a visit each day to the AcroBag jumping site as is required for me to examine the degree of difficulty of the course prior to making my first jump;
- I understand that the access ticket may be used by me alone and is not transferable, and I agree to show it each time I use the facility or when requested to do so;
- I am in good physical and mental health and I am not subject to any disability or physical condition that could constitute a danger in connection with my participation in this activity and I freely agree to participate in this activity. I know that use of the AcroBag is not recommended for persons suffering from heart, back or neck problems and persons who are pregnant;
