COVID-19 SAFETY MEASURES

At Camp Fortune we take your health and safety, as well as that of staff members, seriously. This season you will find all the necessary precautions put into place to ensure the wellbeing of the Camp Fortune Family; both staff and patrons. This will include, but is not limited to, face coverings and goggles on the chairlifts, distancing in the lines, face coverings indoors etc. In accordance with COVID capacity restrictions imposed by Public Health, we will reserve the right to limit the number of people in all indoor spaces when required. Your cooperation will be paramount and we encourage all our guests to come ready to spend as much time outside on the slopes as possible.

Due to the unprecedented events we are experiencing, we at Camp Fortune will be offering a comprehensive credit policy for the 2020-2021 season to ensure that you feel confident in purchasing your Season Pass or Snow School lesson programs with us.

GUARANTEED SEASON POLICY

- Full credit for your season pass if the request is made BEFORE December 15, 2020 and the pass is UNUSED.
- The postponement of your 2020-21 season pass to 2021-22, without any fees and without a price change, if the request is made before December 15, 2020 and the pass is UNUSED.
- Once the ski season has started, or the pass has been used, customers can request a credit for their season pass according to the cancellation policy below. Fees will apply.

2020-21 CANCELLATION POLICY

In addition to the implementation of the Guaranteed Season, several changes have been made to our cancellation policies for the 2020-21 season. For the 2020-2021 ski season, customers will be able to request a credit of their purchase without justification until December 15th. Once the ski season has begun at Camp Fortune (December 15th), the following cancellation policy will be applied automatically to all requests for credits, including those made for medical reasons. The value of the credit, issued in the form of a Camp Fortune gift card, will be based on the number of days the season pass has been used (see grid below). An **administrative fee of \$ 40 + taxes will apply** to all credits issued after a pass has been used.

How to request a credit: To request a credit, the customer must send their request by email to customer service at info@campfortune.com. The following information must be indicated: first and last name, type of season pass or ski school program, email address (to receive confirmation of your credit) and the reason for the request.

MOUNTAIN CODE OF CONDUCT

APPLIES TO ALL CAMP FORTUNE LIFT TICKET HOLDERS, SEASON PASS HOLDERS AND LESSON PARTICIPANTS

Code adopted under the Respecting Safety in Sports Act. This Code applies to all persons practicing snow sports.

- o Remain in control of your speed and direction. Make sure you can stop and avoid any person or obstacle.
- o Yield the right of way to persons downhill and choose a course that ensures their safety.
- o Stop on a trail only if you are visible from above and if you are not obstructing the trail.
- o Yield the right of way to persons uphill when entering a trail and at intersections.
- o If you are involved in or witness an accident, remain at the scene and identify yourself to a first-aider.
- o Use and wear a proper device to prevent runaway equipment at all times.
- o Keep out of the lifts and trails if your ability is impaired through use of alcohol or drugs.
- o Obey all signs and warnings and never venture off the trails or onto a closed trail.
- o Smoking and vaping is only permitted in designated areas. Camp Fortune is a cannabis free resort.

There are elements of risk that common sense and personal awareness can help reduce. Regardless of how you decide to use the slopes, always show courtesy to others. Observe the code listed above and share with others the responsibility for a great outdoor experience. You must obey all other rules and signs pertaining to any particular activity as marked out by the resort.

KNOW THE CODE. BE SAFETY CONSCIOUS. IT IS YOUR RESPONSIBILITY!

The Ticket Holder and Pass Holder are synonymous and for the purpose of this application, ticket holder will be used. The Ticket Holder recognizes, accepts and assumes the inherent risks of snow sliding sports such as skiing and snowboarding. The Ticket Holder assumes all risks of personal injury or any material damage resulting from the said risks. Among others, the following lists the elements considered inherent risks to the normal practice of a snow sliding sport: Changing climatic conditions; Changes in the steepness of the slope; The presence of natural obstacles and any other natural features, such as ditches, crevices and brooks, rocks, earth, uncovered spots, trees, trees regrowth, natural bushes and stumps, etc; Ice and ice patches; Any change to surface condition; Collisions with skiers or other persons; The presence of pylons, poles and any other structures used in the operation of the ski area and collisions with these elements; The use of ski lifts; The presence on the slopes of grooming equipment, emergency vehicles and snowmaking equipment. The presence of icy patches in the parking lot and other outdoor walkways on site . The contract in virtue of which the present lift ticket was issued is subject to the laws in force in Quebec. The holder of the present lift ticket, as well as the issuer of said ticket, agree to elect domicile in the judicial district of Gatineau, province of Quebec and declare that same is the appropriate forum for any and all claims, of whatever nature, arising from the contract in virtue of which the present ticket was issued.

USE OF DRONES ON OUR SITE

The personal and recreational use of drones is strictly prohibited on all Camp Fortune property. The use of drones for commercial purposes could be exceptionally authorized following a written request and authorization from Camp Fortune and the NCC. Compliance with the safety conditions and laws must also be respected. Violation of this policy will result with an expulsion from the site.
