The Parties agree as follows:

- 1. Equipment: the lessor hereby leases to the lessee the equipment contained within this agreement (the agreement).
- 2. Failure to return equipment by **April 9, 2026**, the lessor will be charged the retail value of the package less initial lease payment.
- 3. Damage and Security: the lessee agrees to maintain the equipment in good condition throughout the lease term.
- 4. The lessee also agrees that skis will not be used in terrain parks, specifically on features referred to as boxes and rails. It is expected that the skis will be returned with normal wear and tear that would typically occur in a ski season.
- 5. The equipment will be inspected by the "parties" upon the return of the equipment. Credit card details will be kept on file for use in the case of excessive wear and tear or failure to return equipment.
- 6. Buy-out option: the lessor will have the option to buy the equipment at a cost of the difference between the package price and the initial lease payment at any time during the course of the term,
- 7. Code of Conduct: The lessee agrees to abide by the skier's code of conduct.
- 8. Limits of liability: I (lessee) understand that the ski binding furnished herewith are release units which might release under certain circumstances and thus reduce the risk of degree of injury from falling. As these ski bindings will not release in all circumstances and conditions, they therefore cannot be a guarantee of my safety. I hereby release CAMP FORTUNE, its employees, agents, and servants from any and all responsibility from damage to property and injury to any person including myself resulting from the use of this equipment. I do hereby personally accept full responsibility for any and all such damage and injury and agree to reimburse CAMP FORTUNE, at current replacement cost if any or all of the equipment is lost or stolen and to reimburse CAMP FORTUNE, for any and all damage to the equipment howsoever caused. I further agree that CAMP FORTUNE is exempt from any liability against all losses, damages, costs, charges, and expense which CAMP FORTUNE may sustain in consequence of my use of the equipment leased. The contract in virtue of which the present lease agreement was issued is subject to the laws of Quebec. The holder of the lease agreement as well as the issuer of the lease agreement, agree to elect domicile in the judicial district of Gatineau, in the province of Quebec and declare the same is the appropriate forum for any and all claims, of whatever nature, arising from the contract in virtue of which the present agreement was issued.
